## 2 Year Limited Warranty:

WRIGHT TRAILERS INC, warrants to the original owner that its product will be free from defects in craftsmanship and materials for a period of 2 years. The warranty period begins the day of the purchase by the original end user. A copy of the warranty must be signed by the dealer and purchaser and returned to Wright Trailers Inc within 14 days of the sale of said trailer. Failure to meet this condition will automatically void the warranty.

if any of our products prove to be defective in craftsmanship and/or material under normal use, and the item is returned to Wright Trailers Inc. in Seekonk, MA, and Wright Trailers Inc in its sole discretion finds that the item was defective, the item will be repaired to a functional state or replaced, at Wright Trailers' discretion. Any items replaced during the warranty work will become the property of Wright Trailers Inc. All transportation costs associated with the claim will be the sole responsibility of the purchaser, and will in no way be a part of the manufacturer's warranty. Wright Trailers' also reserves the right to have the item repaired in the field by and approved facility.

This warranty shall be void where Wright Trailers' product has not been properly used, has been altered, neglected, involved in an accident of any kind, or where parts have been added, removed, or modified by any individual other than Wright Trailers Inc. or with Wright Trailers' written consent.

## 90 Day Limited Warranty:

The following items are excluded from the 2 year warranty and are warranted for a period of 90 days from the date of purchase by the original end user: (a) painted finishes. During this 90 day period, the warranty does not cover wear, damage from road debris, sand, salt, scratching, weather conditions or damage caused by inappropriate washing/ waxing solutions or chemicals. (b) Couplers, plumbing, plumbing fixtures, electrical components, lights, locks, jacks, seals and sealent are all covered by Wright Trailers' 90 day limited warranty.

## EXCLUSIONS:

- A:** Wright Trailers makes no warranty with respect to components that are covered by direct manufacturers' warranty to the end user. These items may require registration with cards or online. Examples of this are: axles, tires, wheels, etc as well as electrical items. This warranty exclusion includes any labor expenses involved repairing or replacing any of the foregoing:
- B:** Normal wear items will not be replaced due to wear (including but not limited to bearings, magnets or brake shoes).
- C:** Loading in excess of gross vehicle ratings invalidates all warranties. The ratings are clearly marked on the vehicle ID certificate.
- D:** Damage caused by loose or improperly torqued lug nuts is not covered by warranty.
- E:** Manufacturers' warranty does not cover, in any way, damages caused by acts of God.

## OTHER:

Wright Trailers Inc does not authorize anyone to issue any further, oral or written, warranty other than the express warranty defined herein. Any implied warranty of merchantability and fitness for purpose of is limited to the warranty period of two (2) years. Some states do not allow limitations on the term of implied warranties or the exclusion of incidental or consequential damages, so the limitations may not apply to you. This warranty extends only to the original purchaser below and is not transferable.

By signing this manufacturers' warranty form, the purchaser acknowledges that the dealer has completely explained this warranty and that the purchaser understands and agrees with the the above written warranty and will follow any procedures outlined in the warranty.
